Are there services covered before you meet your deductible ?	Yes. No services are subject to a deductible .	This plan covers some items and services even if you haven't yet met the deductible amount. But a copayment or coinsurance may apply. This plan covers certain preventive services without cost-sharing and before you meet your deductible . Does this plan provide Minimum Essential Coverage? **Yes**
