SECTION 3 - HAZARDS IDENTIFICATION
<b>Emergency Overview</b> Off-white, creamy paste with mild ammoniacal odor. May be harmful if inhaled or swallowed. Inhalation may cause respiratory tract irritation, headache, drowsiness or other effects to the central nervous system. Prolonged or repeated contact may dry skin and cause irritation.
<b>POTENTIAL HEALTH EFFECTS:</b> <b>Primary entry route(s):</b> Skin, eyes, ingestion and inhalation. <b>Target organs:</b> Eyes, skin, respiratory system, central nervous system, digestive system.
<b>Effects of short-term (acute) exposure:</b> <b>Inhalation:</b> May cause irritation to the nose, throat and respiratory tract. Inhalation of higher concentrations could cause dizziness, drowsiness, incoordination and other central nervous system effects.  <b>Skin:</b> Direct skin contact may cause mild irritation.  <b>Eye:</b> Direct eye contact may cause irritation. Symptoms may include stinging, tearing and redness.
<b>Ingestion:</b> May be harmful if swallowed. May cause irritation of the mouth, throat and stomach. This product may present an aspiration hazard if quickly swallowed in large amounts. Aspiration into the lungs could cause life-threatening lung injury.

<b>SECTION 4 - FIRST AID MEASURES</b>

**SECTION 7 - HANDLING AND STORAGE****Safe handling procedures:**

Wear suitable protective equipment. Use with adequate ventilation. Training the workers on the potential health hazards associated with product vapor, dust or fume is important. Secondary inhalation exposures could occur when cleaning equipment, or when removing or laundering the clothing. Avoid breathing vapors, fumes or dust. Avoid contact with eyes, skin and clothing. Keep away from extreme heat and flame. Keep away from oxidizing agents. Avoid and control operations which create high vapor or dust concentrations. Keep container tightly closed when not in use.
